

# 上海政法学院“尚合讲席”项目招聘启事

## 一、项目简介

“尚合讲席”是上海政法学院依托“中国—上海合作组织国际司法交流合作培训基地”（CNISCO）面向上合组织法律大学联盟成员院校设立的高层次外籍专家讲席项目，旨在吸引联盟内的国际知名学者与专业人士，共同推动涉外法治人才培养、国际学术交流与合作研究。

## 二、讲席职责

1. **教学工作：**从指定课程列表中选择并承担一门全英文涉外法治人才培养课程的教学任务，面向本校学生、“尚合青年”项目学员及培训基地学员授课；

2. **科研与智库建设：**提供上海合作组织及其成员国相关史料，撰写说明文字或联合撰写智库报告；

3. **国际合作与交流：**牵头国际交流项目、推荐留学生、组织国际培训、开发教材、举办国际论坛等（根据合同附件选择不少于2项可选任务）；

4. **学术讲座：**面向上海政法学院学生开展不少于2场学术讲座。

## 三、聘任期限

2026 春季学期（即 2026 年 3 月至 7 月）；

工作地点：中国，上海，上海政法学院。

#### 四、薪酬待遇

总薪酬为税前人民币 60,000 元，其中：

劳务报酬：50,000 元（税前），分两期支付；

国际差旅补贴：10,000 元。

学校提供必要的工作支持与办公条件。

具有相关学科博士学位或同等专业资历；

具备良好的英语授课能力，掌握俄语者优先；

具有国际组织、高校或研究机构工作经验者优先；

身心健康，遵守中国法律法规及学校规章制度；

年龄一般不超过 60 周岁。

# **Recruitment Notice for the Shanghe Teaching Fellowship Program of Shanghai University of Political Science and Law**

## **1. Program Introduction**

The "Shanghe Teaching Fellowship" program is a high-level initiative established by Shanghai University of Political Science and Law (SHUPL) through the China National Institute for SCO International Exchange and Judicial Cooperation (CNISCO) and specifically targeting SCO Legal University Alliance member institutions. It aims to attract internationally renowned scholars and professionals from the Alliance to jointly advance the cultivation of foreign-related legal talent, promote international academic exchange, and foster cooperative research.

## **2. Responsibilities**

**Teaching:** Select and undertake the teaching of one course from the designated list for the cultivation of foreign-related legal talent. The course shall be taught in English and will be delivered to SHUPL students, participants of the Shanghe Youth Program, and trainees from the training base.

**Research & Think Tank Development:** Provide historical materials related to the Shanghai Cooperation Organization (SCO)

and its member states, compose relevant explanatory texts, or co-author think tank reports with SHUPL faculty.

**International Cooperation & Exchange:** Lead international exchange projects, recommend international students, organize international training sessions, develop teaching materials, host international forums, etc. (The scholar will select no fewer than two optional tasks as outlined in the contract appendix).

**Academic Lectures:** Deliver no fewer than two academic lectures for the students of Shanghai University of Political Science and Law.

### **3. Contract Term**

Spring Semester, 2026(i.e., March to July 2026).

Location: Shanghai University of Political Science and Law(SHUPL), Shanghai, China.

### **4. Remuneration and Benefits**

Total remuneration is RMB 60,000 (before tax), consisting of:

Service remuneration: RMB 50,000 (before tax), paid in two installments.

International travel allowance: RMB 10,000.

The university will provide necessary working support and office facilities.

### **5. Qualifications**

A Ph.D. or equivalent professional qualification in a relevant field.

Strong ability to teach in English; proficiency in Russian is preferred.

Preference will be given to candidates with professional experience in international organizations, institutions of higher education, or research institutes.

Good physical and mental health, with a commitment to complying with Chinese laws, regulations, and university policies.

Generally, applicants should be under the age of 60.

A list of major academic achievements from the past five years, along with 1-2 representative publications.

One primary course and two alternative course from the designated course list (in case of scheduling conflicts, see Attachment 1).

Two letters of recommendation (in English/Chinese).

A copy of the passport information page.

Other supporting documents (e.g., awards, certificates of employment).
