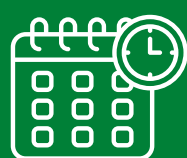

## Introduction

The global political economy is shifting from a largely unipolar system to a multipolar order in which emerging economies, particularly the BRICS countries (Brazil, Russia, India, China and South Africa), play an increasingly influential role in shaping development pathways and international cooperation. At the same time, interconnected challenges such as climate change, inequality, geopolitical fragmentation, technological disruption, and unstable global value chains have exposed the limits of traditional development models and intensified debates on sustainable and inclusive growth, especially in the Global South. Although BRICS cooperation offers a platform for South–South collaboration and institutional reform, these transformations remain underexplored in scholarship, highlighting the need to develop a new generation of researchers capable of analysing the evolving relationships between governance, markets, sustainability, and development in a multipolar world.

The BRICS Postgraduate Forum is an international academic platform specifically created for Master’s and PhD students as well as Postdoctoral Fellows. It serves as a structured international platform dedicated to developing emerging researchers engage critically with global transformation while building research capacity and collaborative networks.

The Forum aims to:

- Advance scholarly dialogue on governance, development and sustainability in a multipolar world
- Strengthen postgraduate research capacity and publication readiness
- Promote interdisciplinary and cross–country academic collaboration
- Support Global South knowledge production
- Encourage policy–relevant research
- Build long–term international scholarly networks

Participants will present papers in a structured three–day academic programme combining student presentations, expert dialogues, and keynote engagements. Outstanding papers recognition will be awarded for Best Master’s Paper and Best PhD Paper based on academic merit and presentation quality. All papers will go for a double–blind peer review, and accepted papers will be considered for publication in a Special Issue and edited book volumes. The forum therefore functions not only as a conference, but as a capacity–building and knowledge–production platform designed to shape the next generation of scholars working on development in a multipolar world.

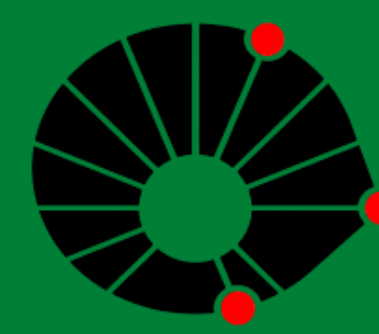
